

# 10th Annual Woodland High School Band Rockathon August 31, 2018

Dear Parents and Students,

Join us in what has become the largest Bartow County school fund raiser ever. **Rockathon 2018** will be a fantastic, all night party to reward the students in recognition of the many dedicated hours they spend soliciting sponsors for the music program.

#### What is it?

The **Rockathon** changes the way we raise money for the band program. Instead of **us** buying more candy bars, cheese cake, frozen pies or wrapping paper, the <u>students and parents</u> will contact local area businesses and offer sponsorship opportunities, complete with a listing in our directory and lots of recognition for their support. There are different sponsorship levels for any donation amount. WBBA will publish a <u>Sponsor's Directory</u> that will be distributed to every family in the Woodland Band. We encourage our band families to use the services offered by our sponsors and build a wide base of community and financial support for the band.

#### What is Our Fund Raising Goal?

With the large number of students in the band program, this year's goal of **\$40,000** should be reachable. This fund raiser has a long history of great success in other school band programs where the parents and students take fund raising seriously. Totals of over \$60,000 are not uncommon! We can do it and it will take everyone contributing their individual efforts to reach our goal. Last year we raised **\$34,000** for our program! **How does it work?** 

Each student receives a packet complete with instructions, sponsorship forms, sponsorship receipts, a sample sponsor's directory, Rockathon party information and a 'Do NOT Contact' List. Students will begin to visit local businesses immediately seeking sponsorships from local businesses/patrons. As students receive money for their efforts, they will turn their money and sponsor information into the collections committee at different times from May through September. When a student reaches the \$100 level, he or she has "qualified" to attend the Rockathon Party on August 31, 2018. Now for the part that can make you money: students will keep 50% of everything they collect over \$100 in their band student **account**. Think of how easy it would be to make enough money to pay your entire band fee or pay for your trips! And, as a bonus, each business that donates to you is automatically "protected" from someone else being able to solicit them next year. You will receive the information from all of your previous sponsors and you, and only you, will be allowed to contact them in the future. After two or three years, you will have a large pool of businesses that have sponsored you in the past and who actually know you and the Woodland Band. If you do a good job of selling the first year, their donations are almost automatic for the next year after they see the Sponsor's Directory and the special certificate you will deliver to them. You can also take donations from anyone (family, friends, etc.) to help you reach your goals. Let's aim for 100% participation in this important project.

There will be music, dancing, volleyball, basketball, food, prizes, video games, lots of chaperones, dodgeball, ultimate frisbee, and who knows what else to entertain us all through the night. Everyone who qualifies (\$100) can attend. All donations must be turned in by Aug. 31st to be able to attend, and yes, you can turn in the money that night! You don't want to miss the fun!!! Donations for the top prizes must be turned in by Aug. 31st. Top-selling students compete for big cash prizes.

Accountants, alterations, air conditioning service, antiques, architecture, art, artists, assisted living, attorneys, banks, bankers, beauty salons, cable companies, carpet, churches, cleaners, computer stores, contractors, doctors and dentists, electricians, florists, health clubs, insurance agents, lawn care, music stores, nail salons, oil companies, pharmacies, plumbers, real estate agents, restaurants, retailers, rental outlets, supermarkets, tanning salons, taxi service, tire stores, veterinarians, weight loss clinics, etc. Just pull out the telephone book!

#### Who should I NOT contact for Donations?

All current sponsors are "protected" and will be contacted for renewal by the student who obtained the previous year's sponsorship. These sponsors are listed in the 'DO NOT CONTACT' list that has been included in this packet. No student, other than the one that obtained the sponsorship, is permitted to contact any sponsor on the 'DO NOT CONTACT' list. If an unauthorized person contacts a sponsor from this list and obtains a renewal, it will be credited to the student who initially obtained the sponsorship, not the student securing the renewal.

New and returning members should spend time focusing on **new** sponsors for the Woodland Band. All new sponsorships and renewals are open now.
